After thoughtful consideration, we have decided to cancel our performance tour of Ireland for March of 2022. COVID protocols in Europe are still too restrictive for us to move forward with planning our performance tour. We are, however, excited to announce that we are planning to relocate our performance tour to Hawaii! (pending board approval). Scheduled during the same 2022 spring break window, this trip will include a once in a lifetime tribute performance at Pearl Harbor as well as many amazing sights around the island of Oahu. Any students and their immediate family members that are not currently signed up for Ireland are welcome to join us and travel to Hawaii. Details of how to add on will be announced soon.

While there are currently COVID protocols in place for travelers to Hawaii (as we are seeing in most cities across the US), we are hopeful that most will be eased as we get closer to the new year. In addition, the band traveled to Hawaii in March of 2017 and the directors are very familiar with the details of this location and performance. We will continue to monitor the situation and we have until December 6th to make an official decision about our travel plans. Below are a few questions and answers about refunds, adding on, and additional information as they relate to the newly relocated performance tour of Hawaii for March of 2022:

- We are currently signed up for Ireland and are now excited to travel to Hawaii with the band. What should we do? Where can I find details about the new trip?
  - There is no action required at this time if you plan to stay on the tour. Your My Gateway account will be updated within one week with the new tour dates, payment dates and cancellation penalty dates based on the new dates of travel.
  - Details of the Hawaii trip can be found on the attached document outlining the tour inclusions and pricing.
- We've already paid in full for the tour of Ireland. Can we still add trip insurance for the Hawaii trip?
  - Yes. Because the price of the trip has increased and no passenger(s) have made their final payment there is an opportunity to purchase insurance. Gateway offers travel insurance with TripMate for individual passengers (or their guardians) to purchase at any time prior to making final payment. This means that your families have time to consider what level of insurance is best for them. While we offer 2 package options, we strongly recommend the Cancel for Any Reason Insurance. This benefit offers that extra bit of security and confidence. Individuals may also privately purchase travel insurance through a provider of their choice. The details of TripMate can be found on My Gateway under the optional insurance section.

- We are interested in traveling to Hawaii with the band, but currently aren't signed up and registered on the Ireland trip. Can we add on and travel for this performance tour?
  - Yes. As soon as the tour is reset on My Gateway, we will send out information on how to register for the new trip.
- We originally signed on for the Ireland performance tour, canceled, and Gateway kept our \$200 non-refundable deposit. Can we apply that \$200 towards the new Hawaii trip?
  - Yes, you can apply the original \$200 deposit towards the Hawaii trip or receive your full refund, either way, contact Gateway at gmf@musicfestivals.com.
- If we decide to cancel now and not travel with the band to Hawaii, how much refund will we receive?
  - o If you are not able to travel on the rescheduled trip to Hawaii in March, please login to your My Gateway account and go to the Passenger tab, click on, Cancel Registration, next to the passenger's name to officially cancel from the tour. This will begin the refund process for your passenger. A refund check will then be mailed to the payer and address on your account. You should receive a refund check 2-3 weeks from the date of cancellation. All passengers that cancel before December 6th will receive a full refund, including the \$200 deposit.
- If travel still appears to be too restrictive and the band cancels the entire group performance tour of Hawaii before December 6, 2021 (96 days) prior to departure, how much refund will we receive?
  - o If the band cancels the entire tour before December 6, all passengers will receive a full refund, including the \$200 deposit.
- If CDC/State travel restrictions force the entire group to cancel on or after December 7, 2021, how much refund will we receive?
  - All passengers would adhere to the terms and conditions on My Gateway (see attached individual cancellation terms outline for your reference). Passengers who purchased the "Cancel for Any Reason" Travel Insurance, plan F465G, can file a claim through TripMate to recover 75% of any non-refundable money paid.
